## Three Basic Criteria to Apply for The Housing Program

- The Ability to Pay: Must have the ability to make an affordable monthly payment on a 30 year mortgage. Total gross annual income must be between our minimum and maximum program requirements, based on household size. (Refer to chart below).

Debt to income ratio must be adequate to make a monthly mortgage payment (Ratio Under 43\%). No outstanding liens or judgments and no outstanding collections totaling more than \$1,000.

- Willingness to Partner: Must provide a minimum of 500 hours of sweat equity towards the completion of your house. Become the face for Habitat which includes participating in annual events, presentations, media interviews, etc.
- Need for adequate shelter: Currently living in substandard conditions, paying 50\% or more of your income to rent, overcrowding issues, etc...

In addition, all applicants must currently work or reside in Jackson County and have done so for at least one year. Applicants must legally reside in the United States.

## HOW TO APPLY

## Step-1 Complete Interested Partner Contact Form

If you feel that you fit the Habitat Housing Program criteria, then please complete the Interested Partner Contact Form and return it to the Habitat Administrative Office. You can do so in the following ways:

Step 2- Application Orientation (Housing Program)
Orientations are held twice a year. The best way to receive an application is to attend an orientation session. This Orientation will answer many important questions regarding our program and the application process. We recommend you attend one of these events. The Orientation marks the opening of a 30-day application window.

## Step 3- Submit Completed Application

Habitat accepts housing applications during a 30-day application window, twice a year. Applications will be available at our office and online during the application window. Any applications received after the 30-day window will not be considered and the applicant will need to reapply. The submission deadline will be listed online and on the application cover page.
